Notice is hereby given that a Bond Election will be held on May 2, 2026, between 7:00 a.m. and 7:00 p.m.

Early voting by personal appearance shall be conducted at the locations and during the hours described on the attached Exhibit "A."

The polling locations on Election Day, May 2, 2026, are attached hereto as Exhibit "B."

Except as otherwise allowed by law, applications for ballots to be voted by mail shall be mailed to the Early Voting Clerk at such address and marked ballots to be voted by mail shall be returned by mail to such address. Applications for ballots by mail must be received no later than the close of business on April 20, 2026.
